










COVID-19 Funding Overview for States, Territories, and Tribes:

Common Requirements and Allowable Use of Funds in the Coronavirus Aid, Relief, and Economic Security (CARES) Act; Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act; and American Rescue Plan (ARP) Act



Stabilization funds



• States/territories/Tribes have until September 30, 2022 to obligate the stabilization funds.

• State/territories/Tribes have until September 30, 2023 to liquidate the funds.








Child Care Stabilization Grant eligibility

Child care businesses must have been licensed, regulated, regulated, or registered and CCDF-eligible on the date of application or registered in the state, tribe, or territory no later than March 11, 2021, and must meet applicable health and safety requirements.

Potential Challenge

 Determining your business's eligibility for ARPA, and any other funds.

Considerations

 Be aware of all possible funding sources.



Taxes

Income may be taxed. Be aware of the tax implications in your area.

Potential Challenge

 Feeling uncertain about how this funding affects your taxes and business.

- What questions do you have about accepting the funding?
- Who will direct your tax questions to?



Attestations

Child care businesses will have to certify and attest to several conditions.

Potential Challenge

- Your state, tribe, or territory may also include additional attestations.
- You may feel unfamiliar with attestations.

- Be aware of federal and local attestation. Make a plan for compliance.
- Ask for interpretations if you need them.



Grant award terms

Cost estimation options:

- 1. Cost estimation model
- Formulas based on enrollment & region
- 3. Survey
- 4. Collect providers' current operating expenses

Local adaptation:

- Timeline
- Monitoring
- Multiple pools of grants

Potential Challenge

Be aware of the grant award terms.

- Outreach: who typically contacts you about child care business opportunities?
- How do you organize and track information about grants?



Allowable uses

- Personnel
- Rent, utilities, facilities, maintenance
- PPE, cleaning, sanitation supplies
- Equipment & supplies
- Goods & services
- Mental health services
- Past expenses

Potential Challenge

 You might be reporting this information for the first time.

- You have what you need to report expenses.
- Ask all of the questions you have!
- Reach out to supports for clarification.



Reporting and monitoring

Potential Challenge

 States, tribes, or territories may ask questions they typically do not ask of child care businesses.

- What reporting information will be required in your state, tribe, or territory?
- Businesses will need to ensure compliance with reporting requirements: deadlines, information required.



Allowable expense categories

Child care businesses can use the grants to cover....

- 1. Personnel costs
- 2. Rent, utilities, facilities, maintenance & insurance
- 3. Personal protective equipment, cleaning, and other health and safety practices
- 4. Equipment and supplies
- 5. Goods and services
- 6. Mental health services
- 7. Past expenses



Personnel costs

Expenses that cover the payment and benefits for people who work in the child care business.

- Payroll records
- Benefits
- Premium pay
- Staff bonuses
- Vaccine-related personnel costs



Rent, utilities, facilities, maintenance & insurance

Payments made for the home or facility where the child care business is located and operates.

- Mortgage or rent payments
- Any fees related to late payments for rent or mortgage
- Insurance
- Utilities expenses
- Maintenance expenses or charges made to address COVID-19
- State, tribe, territory may allow the cost of minor improvements, maintenance or renovations to the child care facility



Goods & services

Payments made to purchases or update supplies to help run the child care business during the COVID-19 crisis.

- Food, snacks, dishes, and other supplies needed for mealtimes and drinks
- Diapers, wipes, & toilet paper
- Toys & games (indoor/outdoor)
- Cribs, sheets and other materials for sleeping
- Books & workbooks
- Craft materials
- Licensing fees and expenses related to maintain license



Equipment and supplies

Payments made for supplies or materials to respond to the COVID-19 pandemic.

- Accounting software
- Payroll software
- Software or material to track and report public health data
- Health monitoring equipment such as thermometers
- Updates to computers, smart phones, and/or tablets



Personal protective equipment, cleaning, and other health and safety practices

Payments made for supplies or materials to keep child care business staff and children safe and healthy during the COVID-19 pandemic.

- Sanitizing wipes, bleach, hand soap, and other cleaning/disinfecting materials
- PPE (face shields, masks, disposable gloves)
- Trainings on proper cleaning & disinfections processes
- Hiring cleaning companies, janitors or other cleaning services
- Ordering background checks & healthy and safety training



Mental health services

Payments made to support the mental health of the child care business' children and staff.

- Infant and early childhood mental consultation
- Mental health consultations for you or your employees



Past expenses

Expenses for the child care business from the start of the public health crisis (January 31, 2020) for any uses related to COVID-19.

- Any receipts for items your business had to pay starting on January 31, 2020, to manage the COVID-19 crisis.
- Each state, tribe, territory may make a decision about whether or not past expenses can be covered by the grants.

Preparing for What Comes Next



Preparation activities

- 1. Assess the benefits and costs of the CCSG opportunity.
- 2. Determine if you are eligible.
- 3. Complete the applications.
- 4. Ask questions and request technical assistance!
- 5. Establish and maintain financial tracking systems.
 - Comprehensive doesn't mean expensive or difficult.

Thinking ahead

Child Care Stabilization Grants

The American Rescue Plan Act of 2021 (ARPA) (Pub. Law 117-2), signed on March 11, 2021, included nearly \$24 billion in Child Care Stabilization Grants to be allocated to states, territories, and Tribes. The goal of the child care stabilization grants is to provide rapid financial relief to child care providers to help them pay for unexpected business costs they faced as a result of the COVID-19 pandemic. By providing much needed economic relief to child care providers, this funding will help them stay open so that that they may continue to serve working families.


