Be a part of the solution

The State of Michigan has made historic investments into child care to provide financial help to child care providers and families struggling to cover costs. With these new expansions, 1 in 3 families in Michigan now qualify for free or low-cost child care through the Child Development and Care (CDC) subsidy program, but many families still do not know about the program, or that they may be newly eligible.

Enclosed in this toolkit, you will find background information, talking points, social media messages, and email inclusions to help spread the word to families and child care providers.

BACKGROUND

The Child Development and Care (CDC) program, also known as Child Care Subsidy, provides child care assistance to eligible families to help reduce or eliminate their costs for child care.

HOW FAMILIES QUALIFY

To qualify, families must:

- ✓ Have a qualifying reason for needing child care:
 - Employment or employment training
 - College or trade classes
 - High school completion program (GED, ESL, ABE)
 - Approved counseling/treatment program
- ✓ Have a qualifying income, which is currently
 200% of the Federal Poverty Level (FPL)
 - Family of 2: \$36,624 annually, or \$17.61/hour
 - Family of 3: \$46,056 annually, or \$22.14/hour
 - Family of 4: \$55,512 annually, or \$26.69/hour
 - See the Child Development and Care Handbook on the <u>CDC Subsidy page</u> for income eligibility for larger households.

FOR PROVIDERS

To accept CDC subsidy from eligible families, child care providers must:

- ✓ Submit billing information every 2 weeks to the Department using I-Billing (internet billing)
- ✓ Keep complete and accurate records of daily time and attendance for children who attend child care with a CDC subsidy (these records must be kept for four years)

Provider Reimbursements:


- ✓ Reimbursement rates are based on the child's age, billed hours, family contribution, provider type, and more
 - Full rate details are available in the <u>CDC handbook</u>
- ✓ Reimbursements can be made via direct deposit, if desired

Talking Points - Why Now?

For Families

Families of 4 making \$55,512 per year now qualify!

Income eligibility is higher than ever before.



Family of 2: \$26,130/year or \$12.56/hour

Family of 3: \$32,940/year or \$15.84/hour

Family of 4: \$39,750/year or \$19.11/hour

Beginning July 2022

Income eligibility is now 200% FPL

Family of 2: \$36,624/year or \$17.61/hour

Family of 3: \$46,056/year or \$22.14/hour

Family of 4: \$55,512/year or \$26.69/hour

Talking Points – Why Now?

For Families

Family contributions are currently \$0 through September 30, 2023.

That means that if you are found eligible for child care subsidy and your provider is accepts subsidy, you will not pay anything out of pocket for child care until September 30, 2023.

Talking Points – Why Now?

For Providers

Provider reimbursement rates have had multiple temporary increases.

As a result of advocacy and input from providers, beginning October 1, 2022, providers accepting child care subsidy will see a permanent 10% rate increase.

First Contact with Subsidy Messages

Higher income audiences:

 Are child care costs hurting your budget? You could be newly eligible for financial relief through a child care subsidy. Michigan has made changes so that more families like yours can send their kids to high-quality child care while keeping more money in your pockets.

• Is the cost of child care overwhelming? You could be eligible for child care assistance and are missing out. Did you know your neighbor down the street with two kids makes over \$40,000 a year, over \$19.50/hour and is receiving money to help with their child care?. Previously Denied

- Were you previously denied for child care subsidy? You may be missing out. Michigan expanded its income eligibility on Oct. 1, 2021 to give more families financial relief. See the most you can earn before taxes are taken out to receive assistance below:
 - Family of two: \$36,624/year or \$17.61/hour
 - Family of three: \$46,056/year or \$22.14/hour
 - Family of four: \$55,512/year or \$26.69/hour

NEW SUBSIDY ELIGIBILITY CALCULATOR

Are child care costs hurting your budget? You could be newly eligible for financial relief through a child care subsidy.

Michigan has made changes so that more families like yours can send their kids to high-quality child care while keeping more money in your pockets. The expansion will allow access to free or low-cost child care for 150,000 more Michigan kids, lowering costs, and helping parents with children under age 12 get back to work.

Eligibility for the CDC program is currently 200% FPL.

 Child care provider reimbursement rates will receive a permanent 10% increase beginning October 1, 2022.
